#### What is it?

An alternative to the 10-year examination to assess cognitive expertise. 25 questions are delivered quarterly on-line over 3-4 years for a total of 300 questions.

Referencing is allowed, along with immediate feedback and critique.

Activity to assess knowledge gaps periodically over time. Instead of 60 topic specific KSA questions at one time, 25 CKSA questions are delivered quarterly online.

Referencing is allowed, along with feedback and critique.

There is no requirement to answer % of questions correctly.

#### What requirement does this meet?

##### Examination

Must Complete Every 10 Years

##### Continuous Certification

Physicians must complete a minimum of 4 CKSA quarters (100 questions) during their stage for CKSA to count as their minimum KSA requirement.

#### Who is eligible?

Diplomates in their 10<sup>th</sup> year of certification and need to fulfill examination requirement.

Diplomates and residents are eligible to participate in CKSA.

#### How do I fulfill this requirement?

Answer 25 questions quarterly on-line over 3-4 years and achieve passing score for a total of 300 questions.

— AND —

In one year, meaningfully participate by answering 75% (75 of 100) of the quarterly questions and participant surveys.

Answer 25 questions quarterly on-line over one year for a total 100 questions.

#### How many points do I earn?

**10 points and 30 CME credits are awarded at the time final results are issued.**

Diplomates must achieve a passing score for 300 questions to receive re-certification for the next 10 years.

**2.5 points and 2.5 CME credits for each completed quarter or 10 points for 4 quarters**

*There is no minimum passing standard for this activity.*

#### Can I revisit the questions?
